Dispatcher: 911 what's the address of your emergency?

Caller 02: Get off our property!

Caller: Keep talking to her keep talking to her

Dispatcher: What's the address?

Caller: There is a uh crazy oh (REDACTED)

Caller 02: Get off our property!

Dispatcher: What's your name sir?

Caller: (REDACTED) There's a crazy person on our property.

Dispatcher: What's your phone number?

Caller: (REDACTED)

Dispatcher: Do you know who she is?

Caller: No idea she has a knife and she just came up randomly like accusing us of some outlandish stuff taking pictures of me and uh, and I would just appreciate if you came and took care of this lady. She is crazy.

Dispatcher: I understand, someone else is gonna send help while I'm talking to you. So you have no idea who she is, but she has a knife?

Caller: No idea who she is. She does have a knife on her.

Caller 02: She's got a knife and there's children outside out across the street.

Dispatcher: Ok, give me a description of her. Is she White, Black, or Hispanic?

Caller: She's white she's about five foot six reddish color hair -

Caller 02: Brown hair.

Caller: -- She's in a burgundy jacket wearing uggs looks like she has camouflage leggings on glasses on top of her head. *Yelling in background*

Caller: but she said she heard screaming she said she heard screaming and that she's concerned about human trafficking coming from our property which is obviously not true but you guys are more than willing to check for that.

Dispatcher: Alright I understand.

Caller: But she took pictures of me she took pictures of me and is claiming that and that can be a defamation case and I want her to delete the pictures.

Caller 02: She's stalking our driveway.

Caller: Yea she just came in the backyard. My dogs were freaking out. It just seems she's cooked out on something.

Dispatcher: Ok where is she right now (REDACTED).

Caller: She's standing in the road outside my driveway. Just walking around. And I really want her to delete these pictures.

Dispatcher: I'm just adding notes to the call. Again someone else has sent help already.

Caller: Ok, she looks like she's about to take off. Yea she's starting to walk away.

Caller 02: She's screaming walking down the road.

Dispatcher: Which direction is she heading?

Caller: She's walking uh south --

Caller 02: Towards (REDACTED)

Caller: -- Towards Harbor Road still got eyes on her.

Dispatcher: Is she anywhere near the children you said were outside.

Caller: No I don't think she crazy like that -

Caller 02: She's having a mental break.

Caller: -- Somethings going on. Like I don't want anything to happen to her. I just want to get her help.

Dispatcher: Right right, you said there were kids there I just want to make sure the kids are safe.

Caller 02: She's coming back.

Caller: Oh yea there fine, she's not that crazy.

Caller 02: Tell her she's coming back.

Dispatcher: She's coming back?

Caller: She seems like some vigilante which I appreciate. But she obviously she's just wrong. She's like there's nothing. You guys are more than welcome to come in and check her allegations.

Dispatcher: Right right no no I understand I understand.

Caller 02: She's in our driveway now.

Dispatcher: She's in your driveway now.

Caller: yea.

Caller 02: She's calling the police.

Dispatcher: I'm just going to stay on the line with you until they get right there with her ok? Just let me

know if she tries to leave -

Caller: That's fine.

Dispatcher: -- or where she tries to go. So she has a knife I want to make sure that the law enforcement gets right there to her.

Caller: Ok... yea definitely. She's got a knife and she's holding a bible. She has a bible in her right arm and her knife and her knife in her left in her left.

Dispatcher: ...holding a bible...

Caller: Now here comes a woman outside from across the street.

Caller 02: Hey be careful she's got a knife.

Dispatcher: Yea if we can just keep everyone away from her –

Caller 02: She has a knife.

Dispatcher: -- Without putting yourself in danger.

Caller 02: We are calling the police.

Dispatcher: Like I said I do have a unit checked enroute to you.

Caller: (background person: do I need to go down there...) No no no the cops are on the way. This lady is

like. There's a lady across the street investigating what in the world is going on as well.

Caller 02: We got the cops on the phone.

Caller: Stop don't let her get away. I them to delete those pictures.

Caller: eh do you guys know this lady? Who is that? You see her around here? She crazy? Yea. Alright the cops are on the way. I'm going to walk down the driveway.

Caller 02: No you're not stay here.

Dispatcher: Is she still at the end of your driveway.

Caller: Yea she's arguing with a lady and she's claiming gas lighting. And she's leaving now. I can hear the

siren, they are going to get here before she gets away that's for sure.

Dispatcher: Alright

Caller: Get off of me (REDACTED) Sorry dogs are jumping on me.

Dispatcher: That's ok I understand.

Caller: There excited about it. Now she's walking off she's going down (REDACTED) she's going like past

(REDACTED) which is what we are on. -

Caller 02: to the left off of (REDACTED.)

Caller: -- Heading east. Yea

Dispatcher: Heading east.

Caller: This is a little excitement I need this. Here comes that lady heading over here

Dispatcher: fighting at the end of your St. Patrick's day. The neighbor is coming over to your house now?

Neighbor: I'm afraid to open this door because the dogs will fly out.

Caller: Here she comes here she comes back.

Neighbor: she's coming back has a knife on her.
